General status of local market

Romania

- Population 19,3 mil
- 43 regional public water companies and 2 private (Veolia)
- 71% of population is connected to public water supply system
- 54% of population is connected to public wastewater system
- NRW: estimated 2019: 42% (55%)









The reason for entering the market

 When Romania started the negotiations to join EU, it opened also a lot of business opportunities for any player in water segment: producers, contractors and consultants.

- Phare, Sapard and ISPA are 3 programs that allowed Romania to get financing for infrastructure before joining EU in 2007.
- After 2007 other 3 financing programs were initiated to continue the infrastructure investments, 2 of these programs having financing from EU: POS (2007-2013) and POIM (2014-2020 – extended to 2023)
- Between 2000 2020, around 7 billion Euro were invested in water and wastewater infrastructure


















Advantages

- Danish companies have a good image on Romanian market, and they are known for providing:
 - High quality products
 - State of the art technologies
 - Models to be followed in simple and reliable way





Challenges

- The market is split: price vs. quality
- Sometimes politic is involved making everything more difficult
- Some procedures could look bureaucratic and slow
- Finding the proper set-up depending business profile.
 For example, AVK has a small set-up in Romania and a strong connection with local distributors.
- Sales may be fluctuating





Water and wastewater – opportunities for 2021 - 2030

Although significant progress has been made in the last years, Romania is still far from achieving the goals established when joined EU.

It is estimated that Romania needs 22,5 billion € to ensure a total compliance with EU directives for water and wastewater.

The main financing programs for water and wastewater are:

- On-going EU financed projects from Large Infrastructure Operational Program (POIM) approx. 4.5 billion € expected to be finalized in 2023
- Sustainable Development Operational Program (PODD) 2021-2027 estimated 3.5 billion €
- The National Recovery and Resilience Plan (PNNR) will include extension of water and sewage networks projects estimated 4 billion €





Conclusions:

- A lot of business opportunities financed from EU funds water and sewage networks and WWTP
- EU financed projects will be available at least 10 more years for water and wastewater
- Quality becomes more and more a decision factor.
