Chile has some of the largest urban populations in Latin America and some of the most densely populated urban areas in the region. The urban sprawl of the country's two capitals, Santiago and Valparaiso, compose some of the largest in the region. City development poses challenges at the planning level, and the authorities are working on addressing the needs.

#### **URBANIZATION IN CHILE**

In 2010, approximately 89 pct. of the Chilean population lived in urban areas. It is estimated that the same number for 2025 will rise to over 90 pct. A booming urbanization has led to an escalation of challenges within transportation, energy efficiency, air pollution, water and waste management, lack of social spaces, quality of public services, housing, etc.

# Santiago de Chile

Santiago de Chile has 5.5 million inhabitants living in the municipality, and 6.7 million inhabitants in the metropolitan area. There is a partnership agreement between Denmark and the Regional Government of Santiago and the Ministry of Environment within urban solutions and environment, and Chile is a formal partner of 3GF/P4G, where smart cities is a key focus point.

The Government in Santiago and the Ministry of Housing and Urban Planning are currently implementing initiatives to improve the quality of life in Santiago. The Ministry of Energy and the Chilean Agency for Energy Efficiency focus on measures to optimize the use of energy in housing and transportation through education. Finally, there is an opportunity for Chile to implement waste-to-energy - transforming household and other organic waste into energy. This is also of great interest to certain sectors such as the agricultural sector that wishes to produce biogas.
